

# ***TREATY CONCERNING THE RIGHTS TO THE FREEDOM OF NAVIGATION ALONG THE BALKAN RIVERS***

## **ARTICLE I**

The signatories of this treaty, being desirous of peaceful and serene interaction between the citizens of their nations, agree that, from the moment of ratification, the rivers of the Balkan Peninsula, including, but not limited to, the Danube, Sava, and Drina, shall henceforth be obstructed by no machinations of the citizens of these nations, but shall be left clear, and shall represent, to the best of each nation's ability, the original state in which these rivers and all others were found.

Furthermore, the citizens of all nations may fight no longer on the Balkan rivers in peacetime, nor may any citizen fire upon foreign nationals who navigate these rivers, excepting those who first violate the terms of this accord and show intent of lethal action. Should such a thing occur, all men are obligated to respond to the violation with swift and deadly force, until the violator of the treaty has felt sufficiently the wrath of all nations.

## **ARTICLE II**

Seeing as all nations attest to the wealth and splendor of the Balkan nations, and seeing as all nations not only wish to attempt, but have made valiant and forthright efforts to preserve their heritage, the signatories hereby agree that, upon ratification, these efforts shall be doubled by the construction of new memorials across the Balkan peninsula, and particularly those structures, both present and planned, which lie upon the Balkan rivers.

Memorials shall also be raised by the signatories to great crimes perpetrated by the Eternal Janitor, in which an excess of of paintings, the estimations of which

have come to greater than six million, were lost to time. Henceforth, this shall be referred to in all official media and publications as the Artocaust.

### ARTICLE III

The signatories allege the crimes of the Macedonians, of the so-called state of "Monkeyzantium," are many and severe, and are as follows:

1. They have attempted to extort the travelers of the Balkans, under the guise of an unlawful tax.
2. They have and continue to harbor an infamous outlaw, Gentlebud, who sought to interrupt this most righteous conference with lethal force.
3. They have remained absent from this conference, thereby indicating their refusal to cooperate with the many nations that surround them.

Therefore, the signatories withhold all the rights and protections afforded by this treaty, including those granted in the previous two articles.

They also promise to attend a future conference, to be held in the city of Zagreb, where they will discuss the terms of a grand alliance against Macedonia, by which they shall be crushed and punished through force, unless they make reparations for their crimes.
